## European Measures of Income, Poverty, and Social Exclusion: Recent Developments and Lessons for U.S. Poverty Measurement

**Purpose:** The U.S. government seems poised to make the first major changes in the official poverty measure in more than forty years. Although the official measure's weaknesses are widely criticized, reform has not been possible because of well-known political obstacles. Less well-known are the conceptual and technical challenges that are intertwined with the political issues posed by any new poverty measure. European researchers and governments face similar issues as they seek to improve their measurement of income, poverty, and well-being.

To learn more about their efforts, the University of Maryland School of Public Policy and the Organisation for Economic Co-operation and Development (OECD) convened more than 100 scholars and government officials from twenty-four countries in Paris, France in March, 2009. In this special APPAM workshop, ten of the European papers selected from the Paris meeting for their relevance to the U.S. situation will be presented and discussed—with ample time for questions and comments from the audience.
